LAND DESCRIPTION

A PARCEL OF LAND BEING A PORTION OF LOT 1, BLOCK 2, PANORAMA OFFICE PARK II, AS RECORDED AT RECEPTION NO. 2370229, SITUATED IN THE NORTHWEST QUARTER OF SECTION 34, TOWNSHIP 5 SOUTH, RANGE 67 WEST OF THE SIXTH PRINCIPAL MERIDIAN, COUNTY OF ARAPAHOE, STATE OF COLORADO, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTHEASTERLY CORNER OF SAID LOT 1, THENCE ALONG THE SOUTHERLY LINE OF SAID LOT 1, 53.59 FEET ALONG THE ARCE OF A CURVE TO THE RIGHT HAVING A CENTRAL ANGLE OF 12°31'53", A RADIUS OF 245.00 FEET AND A CHORD WHICH BEARS S61°35'05"W A DISTANCE OF 53.48 FEET TO THE POINT OF BEGINNING; THENCE CONTINUING ALONG SAID SOUTHERLY LOT LINE, 14.74 FEET ALONG THE ARC OF A CURVE TO THE RIGHT HAVING A CENTRAL ANGLE OF 3°27'00", A RADIUS OF 245.00 FEET AND A CHORD WHICH BEARS S69°34'31"W A DISTANCE OF 14.75 FEET TO THE SOUTHWEST CORNER OF SAID LOT 1; THENCE ALONG THE WESTERLY LINE OF SAID LOT 1, N00°17'55"W A DISTANCE OF 21.18 FEET; THENCE 5.27 FEET ALONG THE ARC OF A NON-TANGENT CURVE TO THE LEFT HAVING A CENTRAL ANGLE OF 1°20'29", A RADIUS OF 225.00 FEET AND A CHORD WHICH BEARS N68°55'35"E A DISTANCE OF 5.27 FEET; THENCE S26°41'58"E A DISTANCE OF 20.07 FEET TO THE POINT OF BEGINNING;

SAID PARCEL CONTAINS 0.005 ACRES, (200 SQUARE FEET), MORE OR LESS.

BEARINGS ARE BASED ON WESTERLY LINE OF THE NORTHWEST QUARTER OF SECTION 34, TOWNSHIP 5 SOUTH, RANGE 37 WEST OF THE SIXTH PRINCIPAL MERIDIAN ASSUMED TO BEAR N00°12'23"W AND BEING MONUMENTED BY A FOUND 3-1/4" ALUMINUM CAP IN RANGE BOX LS #27011 AT THE NORTHWEST CORNER AND A FOUND 3-1/4" ALUMINUM CAP IN RANGE BOX ILLEGIBLE AT THE WEST QUARTER CORNER.
